

Terms of Service for Purchase Orders

This document outlines the terms and conditions governing the purchase of stocks from My Amazon Empire, hereinafter referred to as "the Company." By engaging in the stock purchase process, you, the customer, agree to abide by the following terms:

1. Purchase Agreement:

4. No Order Cancellation Due to Changes:

- Once a stock purchase order is successfully placed and paid for, the customer is not entitled to cancel the order. The customer acknowledges that the stock market is dynamic, and the Company cannot be held responsible for changes beyond its control.

5. Payment:

- Payment for stocks must be made in full at the time of purchase. The Company accepts payment via stripe as encouraged on the invoice. Your payment is subject to verification, and the Company reserves the right to cancel the transaction if payment is not successfully processed.

6. Confirmation of Purchase:

- Upon successful completion of the purchase transaction, you will receive a confirmation email detailing the stock purchase, including the number of products acquired and the total cost.

7. Ownership and Shipment Responsibility:

- Upon successful processing of full payment, ownership of the purchased stocks will be entirely the customers once preparation for the items has been completed. Once the stock leaves the Company's prep centre, the customer assumes full responsibility for any damages or implications that may occur during transit.

8. Tracking and Delivery Accuracy:

- The customer is responsible for tracking the shipment and ensuring the accurate delivery of the purchased stocks to Amazon or any specified destination. Any discrepancies or issues related to the delivery process are the sole responsibility of the customer, and the Company will not be held liable for such matters.

9. Prep Services and Freight Liability:

- For stock purchases that include physical items subject to preparation services (e.g., labelling, packaging), the cost of these services will be itemised and invoiced accordingly. The customer agrees to pay the specified amount for prep services, and failure to do so may result in delays in processing the order.

10. Customer Responsibility for Freight:

- The customer is responsible for organising and covering the costs associated with freight for the shipment of purchased stocks. Any storage costs incurred as a result of delayed freight, whether due to customer actions or external factors, will be at the sole expense of the customer.

11. Freight Organization and Timely Shipment:

- The customer is responsible for providing accurate and timely instructions for freight arrangements. Delays caused by inaccurate or late instructions may result in additional storage costs, which the customer is liable to cover. The Company will not be held responsible for delays caused by the customer's failure to promptly organise freight.

12. No Refunds:

- The customer acknowledges and agrees that, due to the nature of stock market transactions, all stock purchases are final, and the Company does not offer refunds. Once the stock purchase transaction is completed, no refunds will be issued, regardless of subsequent changes in stock prices, market conditions, or any other factors.

13. Changes to Terms:

- The Company reserves the right to modify or update these terms of service at any time. Customers will be notified of any changes, and continued use of the service constitutes acceptance of the revised terms.
